- Growers must have an active trait license for seed purchased

BRIDGE FINANCING

Nutrien Financial customers may register a commitment to lock in the best terms, rates & incentives of the program year, before a prior year’s bill is due, without increasing a credit line. Accounts may not bridge more than the total credit line and must have available credit at time of invoicing.
